
### **2.0. SCOPE OF WORK AND ELIGIBILITY**

#### **2.1 Spa.and.Wellness.Centre**

The Spa and Wellness Center is a 255 square meter space located in the poolside clubhouse on the east side of the hotel premises. The space has been constructed to accommodate up to 4 treatment rooms, sales point, jacuzzi, sauna, steam room, restrooms and lobby space.

At a minimum, the operator will be expected to provide a suitable 3D design, execute construction, and operate spa and wellness services including but not limited to massages, facials, waxing, steam and sauna, body treatments, manicure, nails and pedicure treatments. The operator will be responsible for handling all reservations and points of sales directly with hotel guests and patrons from the public, subject to the terms of a tenancy agreement and standards of operation executed with the hotel management company as the landlord.


To be eligible, the operator must have the following:



- a. CAC registration certificate and good standing with CAC
- b. Appropriate licenses including medical licenses for any cosmetic procedures regulated by the Medical and Dental Practitioners Act
- c. Immediate past three (3) years tax clearance certificates
- d. Professional certifications and/or licensing for each therapist providing services
- e. At least seven (7) years of continuous experience providing spa services to the public
- f. Strong reputation for warm professionalism and positive customer service reviews
- g. Proven track record of profitability and liquidity in operations
- h. Knowledge and experience applying globally tested wellness principles
- i. Comprehensive professional liability insurance
- j. Ability to post a performance bond equivalent to the first year of rent value.

### **3.0. SUBMISSION OF EOI**

- 3.2. Expressions of interest must include
  - 3.2.1. Name of the bidding organization
  - 3.2.2. Number of employees
  - 3.2.3. Ownership and governance structure of the organization
  - 3.2.4. Proof of Eligibility criteria detailed above (note while 3Ds are not required at this stage; they will be required at the proposal stage. It is sufficient to state design and management ideas generally or partners that the bidder intends to work with).
  - 3.2.5. Links to website or social media pages
  - 3.2.6. At least three listed professional or corporate references which could be either from a legal practitioner, accountant, banker or previous landlord.
